Sub : Issuance of No Objection Certificate to Sarada Vidya Mandir, Sudarsanapur, Raiganj, West Bengal - 734 120.

State Government in the School Education Department has issued a provisional "No objection Certificate" to the Sarada Vidya Mandir, Sudarsanapur, Raiganj, West-Bengal dated 02/01/96 for the purpose of preparing its candidates to appear in the examination of the Central Board of Secondary Education under the following conditions :-

1. The State Govt. will not bear any financial burden of the school;
2. The school will not enhance the tuition/other fees without express approval of the State Government;
3. The school will pay its teaching and non-teaching staff emoluments at a rate which should not be less than those of counterparts with equivalent educational qualifications in State-aided educational institutions;
4. The school will provide for contribution to pension of its employees as prescribed under the relevant provisions of Rules of the Govt. of India;
5. 10% (ten percent) of the new admissions in the Lower Secondary year will be allowed on the basis of merit by the School Education Department and 50% of the remaining students to be allowed to prosecute studies in the same at their own cost;
6. The school shall have to furnish periodically to the concerned District Inspector of Schools (primary), concerned District, all the financial information relating to the functioning, its academic activities as and when the same is required by the District Inspector of Schools (primary), concerned District;
7. Violation of any of the conditions laid down in sub-paras (3), (4), (5) and (6) shall entail withdrawal of the "No Objection" of the State Govt. with effect from the beginning of the academic year next to that in which the violation is detected.
